Conditions:

1. This Stallion enrollment form must be mailed and post marked on or before April 30, of said year.
2. A copy of the stallion's registration papers must accompany this form if enrolling your stallion for the first time.
3. The Stallion owner must be a current ECHF member. Membership Fee is due at the time of enrollment.
4. No Mare(s) will be bred prior to February 1st of any year that the stallion is enrolled in the ECHF.
5. The *Regular Enrollment fee is \$500 and the *Gold Enrollment is \$850.00 if paid on or before April 1, of said year. There will be a late fee of \$500.00 for either Gold or Regular enrollment if paid after that date.
6. After the enrollment fee is fully paid, all weanlings, yearling, 2 year old and 3 year olds sired by the above stallion are eligible for competition in the present ECHF Show.
7. There is one free entry per stallion per year and free entries do not roll over to the next year if not used. Free entry is non transferable.
8. Appaloosa, Buckskin, Dun, Paint, Palomino, and Quarter Horse stallions are eligible for the ECHF program.
9. After May 1, of said year, late enrollments into the program will be accepted with the late fee of \$500.00. Postmarked on or before August, 31, of the said year. **Stallion nominations will not be accepted for the present futurities after this date.**
10. ECHF reserves the right to determine all rules and regulations and payouts governing the futurity.
11. No Refunds. Violation of any rule or inaccurate amount of the stud fee nomination will result in immediate and permanent suspension from the program with all fees non-refundable.
